What is a bequest?

A bequest is the act of giving or leaving something by will. You can leave a bequest to an organisaton that you are passionate about and have probably supported for a number of years.

Bequests are recorded in your will, and your solicitor, the Public Trust, or a trustee company will draw up formatted documents for you to sign.

Once you have decided to leave a legacy, it is very important that you discuss your wishes with your family or loved ones to ensure they understand and support your decision to leave a bequest.



Why should I make a will?

Before meeting your lawyer, you might want to estimate the value of your estate. Also consider who you would like to bring as your executor - this person will carry out the provisions in your will in the event of your death.

What information will I need to give my lawyer?

If you are wanting to include Asthma and Respiratory Foundation NZ in your will, take this brochure with you so you can show your lawyer the suggested wording and let them know what type of gift you would like to leave.

What if I already have a Will?

You can amend your existing will to include Asthma and Respiratory Foundation NZ, very simply by asking your lawyer to draw up a 'codicil' - an addition or supplement that explains, modifies, or revokes a will or part of one.
